WHEREAS, Caesars Entertainment Operating Company, Inc. (CEOC), a holding company of casino licensees Boardwalk Regency Corporation (BRC) and Bally's Park Place, Inc. (Bally's) (collectively Petitioners) filed a joint petition on March 30, 2017 as amended May 4, 2017, seeking a ruling from the New Jersey Casino Control Commission (Commission) 1) Determining that Caesars Atlantic City, LLC and Bally's Atlantic City, LLC are required to hold casino service industry enterprise licenses pursuant to N.J.S.A. 5:12-82c in connection with serving as landlords under the long term, triple net lease agreement (Lease), 2) approving the Lease pursuant to N.J.S.A. 5:12-82c, 3) delegating to the Chairman of the Commission the authority to approve amendments to the Lease to the extent that any such amendment does not relate to the "buy-out," "joint and several liability," or "termination" provisions required by N.J.S.A. 5:12-82c(5) and (10) and N.J.S.A. 5:12-104b; and



WHEREAS, CEOC and numerous of its subsidiaries including BRC and Bally's voluntarily filed to reorganize under Chapter 11 of the United States Bankruptcy Code on January 15, 2015; and

WHEREAS, on March 2, 2015, CEOC filed a reorganization plan (Plan) with the U.S. Bankruptcy Court providing for the creation of a real estate investment trust currently known as Rubicon Controlled LLC (REIT) which will ultimately be converted into a corporate real estate investment trust under the laws of the State of Maryland, and

WHEREAS, the Plan was confirmed after a hearing on January 17, 2017; and

WHEREAS, the Plan provides that the REIT will form a series of wholly owned subsidiary limited liability companies which will own the real estate used in connection with the operation of certain gaming facilities owned and operated by CEOC in various jurisdictions; and

WHEREAS, Caesars Atlantic City, LLC (Caesars AC LLC) and Bally's Atlantic City, LLC (Bally's AC LLC) were formed on January 13, 2017, as Delaware limited liability companies; and

WHEREAS, CEOC shall distribute to Caesars AC LLC and Bally's AC LLC the land, buildings, structures, fixtures and other improvements currently owned by and used in connection with the operation of BRC and Bally's; and

WHEREAS, the fixtures distributed to Caesars AC LLC and Bally's AC LLC do not include gaming equipment; and



WHEREAS, the Plan provides that Caesars AC LLC and Bally's AC LLC will lease the land, buildings, structures, fixtures and other improvements currently owned by and used in connection with the operation of BRC and Bally's to separate New Jersey limited liability companies known as Boardwalk Regency, LLC (BR LLC) and Bally's Park Place, LLC (Bally's PP LLC) (collectively Tenants); and

WHEREAS, the Lease has been provided to the Commission and the Division; and

WHEREAS, operating companies BR LLC and Bally's PP LLC will merge with and into BRC and Bally's with BR LLC and Bally's PP LLC surviving; and

WHEREAS, BR LLC and Bally's PP LLC will file a separate petition for the issuance of casino licenses on the same terms and conditions as the valid casino licenses held by BRC and Bally's; and

WHEREAS, by letter dated April 20, 2017, the Division of Gaming Enforcement (Division) recommended that the Commission grant the requested relief with certain conditions; and

FINDINGS and RULINGS

Based upon consideration of the entire record of these proceedings, the Commission issues the following rulings and makes the following findings:

1. Caesars AC, LLC and Bally's AC, LLC are required to hold casino service industry enterprise licenses pursuant to N.J.S.A. 5:12-82c in connection with serving as landlords under the Lease.
2. The Lease is approved pursuant to N.J.S.A. 5:12-82c.
3. The Chairman of the Commission is hereby delegated the authority to approve amendments to the Lease, subject to, and pursuant to the terms and conditions provided herein generally, and specifically condition 7.

CONDITIONS

1. Caesars AC, LLC and Bally's AC, LLC shall provide the Division with all requested information and shall otherwise fully cooperate with the Division in fulfilling its regulatory responsibilities;
2. Caesars AC, LLC and Bally's AC, LLC shall comply with the requirements of N.J.A.C. 13:69J-1.1, et seq., and although they are not holding companies of a casino licensee under the New Jersey Casino Control Act, shall also comply with N.J.A.C. 13:69C-1.1, -1.3, -2.3, -2.5, -2.8, -2.9(a), -8.2 and N.J.A.C. 13:69D-1.4;
3. The REIT shall additionally comply with the requirements of N.J.A.C. 13:69C-8.1, -8.2, -8.6 and N.J.A.C. 13:69D-1.4 and 1.7;




4. The REIT, as a holding company of Caesars AC, LLC and Bally's AC, LLC, shall comply with the Division's financial reporting regulations applicable to casino licensees, including, but not limited to, N.J.A.C. 13:69C-4.1, et seq., where appropriate and as determined by the Division;
5. Caesars AC, LLC, Bally's AC, LLC, BR, LLC, and Bally's PP, LLC shall provide the Division with final copies of the Lease and all other documents expected to operate in connection with the Lease, including, but not limited to the Management and Lease Support Agreement (MLSA), within five days of execution;
6. Caesars AC, LLC, Bally's AC, LLC, BR, LLC, and Bally's PP, LLC shall immediately notify the Division if any party seeks termination of the Lease;
7. Amendments to the Lease as they relate to Caesars AC, LLC, Bally's AC, LLC, BR, LLC, and Bally's PP, LLC are subject to approval by the Commission upon the filing of a petition with the Division and an opportunity for the Division to submit a report regarding such changes. The Chairman through delegated authority may make a determination on any such amendment petition, following receipt of a responsive Division report, if a proposed amendment does not relate to the "buy-out," "joint and several liability," or "termination" provisions required by N.J.S.A. 5:12-82c(5) and (10) and N.J.S.A.



5:12-104b, respectively, which matters must be determined by the full

Commission; and


