RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION  
APPROVING THE AMENDED AND RESTATED STIPULATION OF SETTLEMENT  
CONCERNING THE CONTINUED QUALIFICATION OF  
STEVEN L. SCHEINTHAL TO SERVE AS VICE PRESIDENT AND SECRETARY  
OF GOLDEN NUGGET ATLANTIC CITY, LLC, GOLDEN NUGGET, LLC AND  
FERTITTA ENTERTAINMENT HOLDINGS, LLC

**WHEREAS**, pursuant to N.J.S.A. 5:12-85.1b and c, and N.J.A.C. 13:69C-2.7, certain officers, directors, security holders, principal employees and other persons with the ability to control a casino licensee or a holding company thereof must be individually qualified for approval under the standards, but for residence, governing casino key employees (N.J.S.A. 5:12-89); and

**WHEREAS**, Steven L. Scheinthal holds casino key employee license #9234-11 and serves as Vice President and Secretary of Golden Nugget Atlantic City, LLC (GNAC), Golden Nugget, LLC (GN) and Fertitta Entertainment Holdings, LLC (FEH) and is therefore required to be qualified; and

**WHEREAS**, on May 23, 2011, February 15, 2012 and July 10, 2013, the New Jersey Casino Control Commission (Commission), approved stipulations of settlement between Mr. Scheinthal and the Division of Gaming Enforcement (Division) permitting Mr. Scheinthal to serve as Vice President and Secretary of GNAC, GN and FEH; and

**WHEREAS**, by an amended and restated Stipulation of Settlement (stipulation) dated October 4, 2017 and correspondence dated October 5, 2017,



the Division offered no objection to the Commission finding that Mr. Scheinthal remains qualified to serve as Vice President and Secretary of GNAC, GN and FEH subject to the terms of the October 4, 2017 stipulation; and

**WHEREAS**, on August 12, 2015, the Commission granted casino licensure to Resorts Digital Gaming, LLC (Resorts Digital) as an internet gaming affiliate of DGMB pursuant to *N.J.S.A. 5:12-95.32* and *N.J.S.A. 5:12-82b(5)*; found DGMB SPE, DGMB Casino Holding and JEMB qualified as holding companies of Resorts Digital and found Joseph Jerome, among others, qualified as a natural person qualifier of Resorts Digital (Resolution No. 15-08-12-12); and



**WHEREAS**, in October 2016, pursuant to *N.J.S.A.* 5:12-87.1, the Division of Gaming Enforcement (Division) reviewed the casino license of DGMB and its holding companies, entity qualifiers and natural person qualifiers, including, among others, DGMB Casino Holding, DGMB SPE, JEMB, the 2010 Trusts, Joseph Jerome and Michele Bailey-Horovits and determined that DGMB, its holding companies, entity qualifiers and natural person qualifiers continued to meet the requirements for licensure as set forth in *N.J.S.A.* 5:12-84 and -85; and

**WHEREAS**, on August 29, 2017, as amended on September 29, 2017, DGMB and Resorts Digital and their holding companies DGMB Casino Holding, DGMB SPE and JEMB filed PRN 2411702 seeking approval of the transfer of an ownership interest in JEMB from the 2010 Trusts to the Bailey Family 1998 Grandchildren's Trust (1998 Trust) pursuant to *N.J.S.A.* 5:12-105f and qualification of the 1998 Trust as a new entity qualifier of DGMB and Resorts Digital, as well as qualification of Ester Jerome as Trustee of the 1998 Trust; and

**WHEREAS**, the 2010 Trusts propose to contribute forty-five percent (45%) of its fifty percent (50%) ownership interest in JEMB to the 1998 Trust of which Michele Bailey-Horovits and Ester Jerome are the Trustees and the remaining five percent (5%) to five (5) individuals, each of whom will thereafter hold a one percent (1%) interest each in JEMB; and

**WHEREAS**, the Division filed a letter report dated October 3, 2017 concluding that it would not object to the approval of the ownership interest




