Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

- 1. By a vote of 3-0, ratified the minutes of November 21, 2012 public meeting (transcript pages 8-9).
- 2. The Commission unanimously approved the 2013 Annual Meeting Schedule (ruling number 12-12-02; transcript pages 9-10).
- 3. The Commission unanimously adopted Resolution No. 12-12-12-03 permitting the Commission to hold a closed session before each scheduled public meeting in 2013 (ruling number 12-12-12-03; transcript pages 10-11).

- By a vote of 3-0, approved the termination of the casino key employee licenses held by Mohammed K. Al-Farook, Mary L. Cheeks-Toombs, Kevin M. Entress, David W. Ingersoll, Edward T. Knurek and Mary D. Wilson (Ruling numbers 12-12-12-08-A; 12-12-12-08-B; 12-12-12-08-C; 12-12-12-08-D; 12-12-12-08-E; 12-12-12-08-F; 12-12-12-08-G; transcript pages 16-18).
- 9. By a vote of 3-0, approved the stipulation of settlement and granted the application of James M. Knights for a casino key employee license (DKT-12-0007-CK) (Ruling number 12-12-12-09; transcript pages 18-20).
- 10. By a vote of 3-0, approved the stipulation of settlement and granted the application of Mark J. Evans for a casino key employee license (DKT-12-0011-CK) (Ruling number 12-12-10; transcript pages 20-22).

- 11. By a vote of 3-0, approved the stipulation of settlement and granted the application of Walter M. Brown for a casino key employee license (DKT-12-0008-CK) (Ruling number 12-12-11; transcript pages 22-24).
- 12. By a vote of 3-0, approved the stipulation of settlement and granted the application of Francis A. Foti for a casino key employee license (DKT-12-0010-CK) (Ruling number 12-12-12; transcript pages 24-26).
- 13. Considered the petition of Revel Entertainment Group, LLC. and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Darlene Monzo, on a temporary basis and prior to her plenary qualification, to assume the duties and exercise the powers of Senior Vice President of Marketing for Revel Entertainment Group, LLC, subject to the conditions contained in *N.J.S.A.* 5:12-85.1 c; *N.J.S.A.* 5:12-89b (1), *N.J.S.A.* 5:12-89b (2) and *N.J.A.C* 13:69C-2.6 (DGE-PRN 3331201) (ruling number 12-12-13; transcript pages 26-29).

14. Considered the petition of Caesars Entertainment Corporation and Caesars Entertainment Operating Company, Inc. and issued the following ruling:

By a vote of 3-0, found good cause and granted the requested relief and extended the period of temporary qualification, to permit Thomas M. Jenkin, to continue to serve as President of Operations for Caesars Entertainment Corporation and Caesars Entertainment Operating Company, Inc., for a period not to exceed 30 days from December 12, 2012, subject to the conditions in the *N.J.A.C.* 13:69C-2.7 (DGE PRN 340120) (12-12-12-14; transcript pages 29-32).

15. By a vote of 3-0, adopted the draft resolution and found Dennis Neilander qualified to serve as a Member of the Compliance Committee for Caesars Entertainment Corporation, in accordance with *N.J.S.A.* 5:12-85.1c, *N.J.S.A.* 5:12-85.1d, *N.J.S.A.* 5:12-89b (1), *N.J.S.A.* 5:12-89b (2) and *N.J.A.C.* 13:69C-2.7 (ruling number 12-12-12-15; transcript pages 32-34).
