WHEREAS, the State of New Jersey, through the Division of Gaming Enforcement operates a Self-Exclusion program and, through fees imposed on




casinos, the state provides financial support for the Council on Compulsive Gambling of New Jersey and its 24-hour-a-day 1-800-GAMBLER hotline; and


