**RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE PETITION OF BOARDWALK 1000, LLC AND HR ATLANTIC CITY, LLC FOR THE ISSUANCE OF TEMPORARY CASINO KEY EMPLOYEE LICENSES AND MULTI-CASINO ENDORSEMENTS, PURSUANT TO N.J.S.A. 5:12-89e, N.J.A.C. 19:41A-5.3 and N.J.A.C. 19:41A-5.4 (PRN 1451802)**

("IRS") and provide the Division with proof of compliance with the payment plan on an annual basis beginning May 15, 2019; and



**IT IS FURTHER ORDERED** that Respondent is prohibited from applying for or holding any license, registration, qualification, or approval required under the Casino Control Act, or working in any Atlantic City casino-hotel in a position that does not require a license or registration, except as provided in this Order or as permitted by N.J.A.C. 13:69A-8.8, N.J.A.C. 13:69A-8.9, N.J.A.C. 13:69A-8.10 or N.J.A.C. 13:69A-8.11.


**WHEREAS** the Division of Gaming Enforcement (Division) filed a letter-report dated May 29, 2018, identified as D-1, recommending that the



Commission grant the requested relief subject to the continuation of the conditions set forth in Resolution No. 17-12-19-18; and


**WHEREAS** the Commission considered the entire matter at its public meeting on June 6, 2018;

**WHEREAS**, AC Ocean Walk LLC (AC Ocean), an applicant for a casino license, filed a petition on April 5, 2018 seeking a ruling from the New Jersey Casino Control Commission (Commission) 1) determining that ACOWRE, LLC (ACOWRE) is required to hold a casino service industry enterprise license pursuant to *N.J.S.A. 5:12-82c* in connection with serving as the Landlord under the Amended and Restated Operating Lease (Lease), (2) approving the Lease pursuant to *N.J.S.A. 5:12-82c*, (3) delegating to the Chairman of the Commission the authority to approve amendments to the Lease to the extent that any such amendment does not relate to the “buy-out,” “joint and several liability,” or “termination” provisions required by *N.J.S.A. 5:12-82c(5)* and (10) and *N.J.S.A. 5:12-104b* of the Casino Control Act (Act); and

**WHEREAS**, the Lease has been provided to the Commission and the Division of Gaming Enforcement (Division); and

**WHEREAS**, AC Ocean will file a separate petition for the issuance of a casino license; and



**WHEREAS**, the Division by letter report dated May 15, 2018 recommended that the Commission grant the requested relief with certain conditions; and

**WHEREAS**, the Commission considered the entire record of this matter at its public meeting on June 6, 2018.

**NOW, THEREFORE, BE IT RESOLVED** by the Commission that the requested relief is hereby **GRANTED** based upon and to the extent set forth in the findings and rulings, and subject to the conditions contained in this Resolution as follows:

**FINDINGS and RULINGS**

Based upon consideration of the entire record of these proceedings, the Commission issues the following rulings and makes the following findings:

1. ACOWRE is required to hold a casino service industry enterprise license pursuant to *N.J.S.A. 5:12-82c* in connection with serving as Landlord under the Lease.
2. The Lease is approved pursuant to *N.J.S.A. 5:12-82c*.
3. The Chairman of the Commission is hereby delegated the authority to approve amendments to the Lease, subject to, and pursuant to the terms and conditions provided herein generally, and specifically condition 4.




**CONDITIONS**

1. ACOWRE shall provide the Division with all requested information and shall otherwise fully cooperate with the Division in fulfilling its regulatory responsibilities;
2. ACOWRE shall comply with the requirements of *N.J.A.C. 13:69J-1.1*, et seq., and although not a holding company of a casino licensee under the Act, shall also comply with *N.J.A.C. 13:69C-1.1*, -1.3, -2.3, -2.5, -2.8, -2.9(a), -8.2 and *N.J.A.C. 13:69D-1.4*;
3. ACOWRE and AC Ocean shall immediately notify the Division if any party seeks termination of the Lease;
4. Amendments to the Lease are subject to approval by the Commission upon the filing of a petition with the Division and an opportunity for the Division to submit a report regarding such changes. The Chairman through delegated authority may make a determination on any such amendment petition, following receipt of a responsive Division report, if a proposed amendment does not relate to the "buy-out," "joint and several liability," or "termination" provisions required by *N.J.S.A. 5:12-82c(5)* and (10) and *N.J.S.A. 5:12-104b*, respectively, which matters must be determined by the full Commission; and
5. The requirements as set forth in the above Conditions shall not be modified or eliminated except with the approval of the Division Director




