WHEREAS, Eldorado Resorts, Inc. (ERI), an applicant for interim casino authorization, Delta Merger Sub (Delta Sub), a wholly owned subsidiary of ERI, and GLP Capital, L.P. (GLP), a subsidiary of Gaming and Leisure Properties, Inc., a publicly traded Pennsylvania real estate investment trust, (collectively, Petitioners) filed a joint petition on June 20, 2018 which was supplemented on July 30, 2018, seeking a ruling from the New Jersey Casino Control Commission (Commission) (1) determining that Tropicana AC Sub Corp. (Trop Sub) is required to hold a casino service industry enterprise license pursuant to *N.J.S.A. 5:12-82c* in connection with serving as the Landlord under the Master Lease Agreement (Master Lease) between GLP and Trop Sub as Landlords and Tropicana Entertainment, Inc. (TEI) and Tropicana Atlantic City Corp., d/b/a Tropicana Casino & Resort (Trop AC) as Tenants (2) approving the Master Lease pursuant to *N.J.S.A. 5:12-82c*, and (3) delegating to the Chairman of the Commission the authority to approve amendments to the Master Lease to the extent that any such amendment does not relate to the “buy-out,” “joint and several liability,” or “termination” provisions required by



N.J.S.A. 5:12-82c(5) and (10) and N.J.S.A. 5:12-104b of the Casino Control Act (Act); and

WHEREAS, the Master Lease has been provided to the Commission and the Division of Gaming Enforcement (Division); and

WHEREAS, ERI has filed a separate petition for interim casino authorization pending plenary qualification (PRN 1351803); and

WHEREAS, the Division of Gaming Enforcement (Division) by letter report filed July 31, 2018 recommended that the Commission grant the requested relief with certain conditions; and

WHEREAS, the Commission considered the entire record of this matter at its public meeting on August 8, 2018.

NOW, THEREFORE, BE IT RESOLVED by the Commission that the requested relief is hereby **GRANTED** based upon and to the extent set forth in the findings and rulings, and subject to the conditions contained in this Resolution as follows:

FINDINGS and RULINGS

Based upon consideration of the entire record of these proceedings, the Commission issues the following rulings and makes the following findings:

1. Trop Sub is required to hold a casino service industry enterprise license pursuant to *N.J.S.A. 5:12-82c* in connection with serving as Landlord under the Master Lease.
2. The Master Lease is approved pursuant to *N.J.S.A. 5:12-82c*.



3. The Chairman of the Commission is hereby delegated the authority to approve amendments to the Master Lease, subject to, and pursuant to the terms and conditions provided herein generally, and specifically condition 7.

CONDITIONS

1. Trop Sub shall provide the Division with all requested information and shall otherwise fully cooperate with the Division in fulfilling its regulatory responsibilities;
2. Trop Sub shall comply with the requirements of *N.J.A.C. 13:69J-1.1*, et seq., and although not a holding company of a casino licensee under the Act, shall also comply with *N.J.A.C. 13:69C-1.1*, -1.3, -2.3, -2.5, -2.8, -2.9(a), -8.2 and *N.J.A.C. 13:69D-1.4*;
3. GLP, as a holding company of Trop Sub, shall additionally comply with the requirements of *N.J.A.C. 13:69C-8.1*, -8.2, -8.6 and *N.J.A.C. 13:69D-1.4* and 1.7;
4. GLP, as a holding company of Trop Sub, shall comply with the Division's financial reporting regulations applicable to casino licensees, including, but not limited to, *N.J.A.C. 13:69C-4.1*, et seq., where appropriate and as determined by the Division;
5. Trop Sub shall provide the Division with final copies of the Master Lease within five days of execution;



6. Trop Sub, TEI and GLP shall immediately notify the Division if any party seeks termination of the Lease;
7. Amendments to the Master Lease as they relate to Trop AC are subject to approval by the Commission upon the filing of a petition with the Division and an opportunity for the Division to submit a report regarding such changes. The Chairman through delegated authority may make a determination on any such amendment petition, following receipt of a responsive Division report, if a proposed amendment does not relate to the “buy-out,” “joint and several liability,” or “termination” provisions required by *N.J.S.A. 5:12-82c(5) and (10) and -104b*, respectively, which matters must be determined by the full Commission; and
8. The requirements as set forth in the above Conditions shall not be modified or eliminated except with the approval of the Division Director or his designee, with notice of such approval directed to the Chairman of the Commission.
