**ORDER SUSPENDING
CASINO KEY EMPLOYEE
LICENSE**

An application for suspension and a complaint for revocation of the casino key employee license #9479-11 of Lee J. Sanchez (“**Respondent**”) having been filed by the Division of Gaming Enforcement (“**Division**”); and the Division having alleged that on May 23, 2018, Respondent was charged with one count of Criminal Sexual Contact, fourth degree, contrary to N.J.S.A. 2C:14-3B; and the Division having further alleged that on July 24, 2018, Respondent was indicted with one count of Criminal Sexual Contact, fourth degree, contrary to N.J.S.A. 2C:14-3B; and Respondent having been given an opportunity to respond to the Division’s allegations; and the New Jersey Casino Control Commission (“**Commission**”) having considered the application for suspension at its public meeting of October 10, 2018,

IT IS on this *10th* day of *October 2018*, **ORDERED** that Respondent’s casino key employee license #9479-11 is **SUSPENDED** for good cause shown, pursuant to N.J.S.A. 5:12-75 and N.J.S.A. 5:12-86, pending the final disposition of the complaint or until further Order of the Commission; and

IT IS FURTHER ORDERED that, during the pendency of this suspension, Respondent is prohibited from employment in any capacity by a casino licensee, including any position that does not require a credential pursuant to N.J.S.A. 5:12-106(c) unless otherwise permitted by law; and

IT IS FURTHER ORDERED that, if Respondent so requests, a deferral will be granted pursuant to N.J.S.A. 5:12-86(d); and
